HOW TO APPLY FOR AG PERMIT/RENEWAL



If you are applying for an Ag Permit or wish to renew your Ag Permit the state now has required all Oklahoma County Taxpayers to apply/renew online. **You will need to provide a 1040F (or another proof of farming for profit as a new requirement when applying or renewing).** If renewing, you will need to have your current exemption card available to provide current member account number. Follow the steps below to apply/renew AG Permits online or call the Oklahoma Tax Commission (401) 521-3160. Don't forget all Osage County Taxes have to be paid up to date to the Osage County Treasurer's Office before renewing or applying for an Ag Permit.

Go to osagecountyassessor.com - click on links at the top right corner click **AG Permit Info**. **Apply** or you can go to <https://oktap.tax.ok.gov/oktap/web>



Must click all that apply to you in each circle and provide 1040F as an attached document or provide a letter to attach if you answered yes to any of the qualifying questions.

When filling out (2) Applicant Information you must fill out every box listed. If you are renewing, you have to put the social security number in you used to file your current Ag Permit Card. (permit # EXM-99999999-01 this is on current card, if you do not have a card you will not see this option if you are applying new. (Trade name put your name or farm name and phone #) then click next.

When filling out (3) Address Information click on the *identify mailing address* under state to verify your address it might prefill but you still have to hit save and then you should be able to click next once you confirm the correct address.

When filling out (4) **Agricultural Transactions** fill in all that applies to you. You may need to click add/remove machinery (this can be found on OTC form 924 provided by the Assessor's Office) Once you have filled out all click the next button.

When filling out (5) **Sign**, type in electronic signature how name is on card or how you would like to sign your name as well as the date and click **Digital Signature** box then click next.
